<b>REASON</b>	<p>We have been informed by Torrent Pharmaceuticals Limited that they are voluntarily recalling the product indicated in the above table. This recall was initiated due to “the detection of trace amounts of an unexpected impurity found in an active pharmaceutical ingredient (API) manufactured by Hetero Labs Limited. The impurity in the API is N-nitrosodiethylamine (NDEA), which is a substance that occurs naturally in certain foods, drinking water, air pollution and industrial processes and has been classified as a probable human carcinogen as per International Agency for Research on Cancer (IARC) classification.”</p>
